SENIOR FELLOWS LEARNED TECHNIQUES TESTED AND TRUE WHICH MINIMIZE BIAS IN OUR BRAINS AND ALLOW US TO ADDRESS BIAS IN THE WORKPLACE AND INSIDE INSTITUTIONS.
